Resolution II.

The Circle of Presidents of the Conference of European Constitutional Courts, gathered in Prague in preparation of the XVIIIth Congress of the Conference of European Constitutional Courts on June 13, 2018,

unanimously decides

to approve certain organizational matters related to the preparation of the XVIIIth Congress of the Conference of European Constitutional Courts in accordance with Art. 9 para. 2 of the Statute, as follows:

- 1) The XVIIIth Congress of the Conference of European Constitutional Courts will take place in Prague from 26 to 29 May 2020. (Art. 9 para. 2 lit. c and para. 5 of the Statute).
- 2) Unless any of the member courts asks for interpretation to be provided into another language as per Art. 9 para. 2 lit. c) of the Statute, then the languages of the XVIIIth Congress of the Conference of European Constitutional Courts will be French, English, German, Russian and Czech (Art. 9 para. 2 lit. c) of the Statute; Art. 12 of the Conference Regulations).
- 3) The Czech Constitutional Court will issue a questionnaire for the XVIIIth Congress of the Conference of European Constitutional Courts by December 31, 2018 and will send it to the member courts for comments. After incorporating the comments, but by February 28, 2019 at the latest, the final version of the questionnaire will be sent to the individual member courts for processing. The completed questionnaire will be returned to the Secretariat of the Conference of European Constitutional Courts by October 31, 2019 in the national language of the member court and in English or French (Art. 3 of the Conference Regulations).
- 4) The Vice-President of the Constitutional Court of the Czech Republic, Mr Jaroslav Fenyk, is hereby designated the General Rapporteur of the XVIIIth Congress of the Conference of European Constitutional Courts (Art. 3 of the Conference Regulations).

- 5) The persons and institutions listed in the annex to this resolution will be invited as observers and guests to the XVIIIth Congress of the Conference of European Constitutional Courts (Art. 9 para. 2 lit. b) of the Statute; Art. 5 para. 1 and 2 of the Conference Regulations). The delegation of a member court participating in the XVIIIth Congress of the Conference of European Constitutional Courts can be made up of 5 people.
- 6) The Venice Commission of the Council of Europe is asked to cooperate in the preparations of the XVIIIth Congress of the Conference of European Constitutional Courts. The Venice Commission will prepare a special Bulletin for the XVIIIth Congress of the Conference of European Constitutional Courts.
